Vendors wristbands will be given when vendors come to set up. **No pets are allowed. If children are to accompany you, they should remain within your booth and not allowed free access to the grounds without adult supervision. No throwing toys are allowed.**

Hours of the event are from 12 noon to 7 p.m. both Saturday and Sunday. Vendors will be issued ID bracelets. This identifies you and allows you to purchase wines. No bracelets will be given to underage vendor employees. Vendors share an entrance with volunteers, handicapped and bands. Please observe the handicapped parking area. Please do not bring pets to the festival.
