* TEAR DOWN: Sunday-October 1st after 7 P.m. NO VENDOR WILL BE ALLOWED TO TEAR DOWN PRIOR TO THE END OF THE SHOW FOR SAFETY REASONS.

Each day after the event, vendors should remove all trash to the dumpster. Individual trash containers are for our public. Please provide at least one trash receptacle of your own for public use. If you smoke, please provide an ashtray and use it. This is our yard.

Each food vendor must present a copy of their liability insurance coverage in an amount not less than \$500,000 and contact NM Environ- mental for permits (10 days in advance of the event). ITEMS TO BE SOLD (LIMIT OF 6 F ITEMS - BE SPECIFIC).

Hours of the event are from 12 noon to 7 p.m. both Saturday and Sunday. Vendors will be issued ID bracelets. This identifies you and allows you to purchase wines. No bracelets will be given to underage vendor employees. Vendors share an entrance with volunteers, handicapped and bands. Please observe the handicapped parking area. **Vendors are not allowed to bring pets**
